Sub:- RTI Appeal filed by Shri Romee.

Shri Romee has filed an appeal vide Registration No.DoP&T/A/E/22/00529, dated 19.5.2022 in respect of his RTI Application Registration No.DoP&T/R/E/22/02305 dated 28.4.2022.

2. The appeal has been perused and it is seen that the appellant vide his RTI application had desired information regarding reservation for OBCs in Chhattisgarh State by the Central Government. He has further informed that the CPIO has not furnished the details and has also refused access to information requested.

3. It is seen that CPIO, informed the appellant to refer to the Brochure on Reservation which is a detailed document containing various policy instructions relating to reservation in appointments under the Central Government which is available on the website of this Department. However, the appellant is not satisfied with the reply and has preferred an appeal.

4. As per the RTI Act, the CPIO is required to provide information in material form as may be available with him. He is not supposed to create information or to interpret information or to give clarification. The CPIO has provided the information as available with him and has also given the link on which the relevant documents are available. However, in view of the appeal, copies of this RTI appeal as well as the RTI application of Shri Romee are forwarded to the Appellate Authority of Department of Financial Services(in respect of IBPS) and DS(E.II) and Appellate Authority, DoPT (in respect of SSC) for necessary action. Accordingly, the appeal is disposed of.

5. If the appellant is not satisfied with the order, he may make an appeal to the Central Information Commission, CIC Bhawan, Baba Gang Nath Marg, Munirka, New Delhi within 90 days of receipt of this Order.
