1. Kindly refer DOPT OMs – (a) 3/1/85-Estt(Pay-II) dated 31.07.1986 (b) 3/13/2008-Estt(Pay-II) dated 11.11.2008 (c) 3/19/2009-Estt(Pay-II) dated 05.04.2010 and (d) 3/19/2009-Estt(Pay-II) dated 08.11.2010. These OMs are deals with **pay fixation** of re-employed pensioners/ex-servicemen Officers and **Personnel Below Officer Rank**. These instructions have already been implemented by various Ministries/Departments with whom the facts of the case/details of officers and posts are available. The instructions issued by DOPT are applicable to Central Government Civilian Employees as well as ex-servicemen and posts. These are not directly/suo motu applicable to Autonomous Bodies, PSUs, Trusts or Banks etc, which are governed by their own set of rules regulations. But, as far as the pay fixation subject/matter of re-employed ex-servicemen, working/serving under different autonomous bodies/nodal agencies/statutory bodies/independent bodies/PSUs have also been adopted/implemented and continuing till date by different ways/methods/procedures as per their own set of rules and regulations without any obligations. After implementation of the recommendations of the 6th CPC and the issue of CCS (RP) Rules 2008, the system of Running Pay Bands and Grade Pays introduced. Accordingly, the method/procedure of pay fixation has also been partially modified and issued necessary guidelines for the appointees on or after 1.1.2006, but the method/procedure of pay fixation of re-employed ex-servicemen is continuing till date by all above administrative authorities.
2. Sir, as per the above said OMs, it is clearly mentioned that at the time of re-employment/joining of an ex-servicemen under ex-servicemen quota on his new appointment, the appointing/concerned administrative authorities are solely responsible and they are bound to give the opportunity to the re-employed ex-servicemen for exercising their option for pay fixation on re-employment.
3. Sir, kindly provide the information that, the complete details and particulars of all re-employed ex-servicemen (like Name, category, date of re-employment in Group C or Group D, presently working with the name of Ministry/department/autonomous body/nodal agency/statutory body/independent body/institution name and appointment holding etc...).
4. Sir, kindly provide the information that, as per above mentioned OMs at para 1 of above have been adopted, implemented and continuing till date and assured in true spirit of the benefit of pay fixation has reached to all those re-employed ex-servicemen working under your jurisdiction.
5. Sir, kindly provide detail information of the procedure/method of pay fixation, correct letter, correct rule position and the correct para and the correct CCS (RP) Rule have been adopted, implemented and continuing till date by your administrative level to all those re-employed ex-servicemen working under your jurisdiction.
6. Sir, kindly provide the information in detail with complete valid and justified reasons that the steps/measures have been taken so far till date, if not adopted/implemented and to rectifying the anomalies of the procedure/method of pay fixation.
7. Sir, kindly provide the information that, after adopted/implemented the method and procedure of pay fixation to the re-employed ex-servicemen, is there any audit objections raised by the audit authorities concerned. If they any, then kindly provide the true copies of steps/measures have been taken at your concerned administrative level to settle this matter.

8. Sir, kindly provide the information that, if the pay fixation has been done only after a order/judgement received from concerned/respective Central Administrative Tribunal/High Court/Supreme Court. If they any, then kindly provide the true copies of their OA/WP/SLP and the order/judgement copies of all those re-employed ex-servicemen persons.

9. Sir, kindly provide the information that, at the time of pay fixation what are the elements are to be taken after the re-employment of ex-servicemen working under your administration/jurisdiction (i.e, those elements which are reflected in PPO/last pay drawn or by granting/adding the advance increments of number of years rendered/served in the Defence Force or , from the both of above which is higher that has to be taken for initial pay fixation as per reference of DOPT OM No. 16/3/85-Estt(Pay I) dated 22 Jan 1987.

10. Sir, kindly provide the complete information of procedure of pay fixation of a Combatant Clerk/Personal Assistant (English Stenographer)/Store Keeper (i.e, treated as a LDC and entitled/granting/allowing the advance increments) after the re-employment of ex-servicemen working under your administration/jurisdiction.

11. Sir, kindly provide the detail information that, after introduction of New Pension Scheme wef 01.01.2004, what are the steps/methods/procedures have been adopted towards the pay fixation of all those re-employed ex-servicemen working under your administration/jurisdiction before 01.01.2006 and after 01.01.2006 separately.

12. Sir, kindly arrange to provide the all certified true copies of the file proceedings and notings prior to making re-fixation of pay to the all re-employment of ex-servicemen working under your administration/jurisdiction before 01.01.2006 and after 01.01.2006 separately.

13. Sir, kindly arrange to provide the all certified true copies of arrears bill payments after re-fixation of pay to all re-employment of ex-servicemen working under your administration/jurisdiction before 01.01.2006 and after 01.01.2006 separately.

14. Sir, kindly arrange to provide the all certified true copies of re-pay fixation orders in respect of all those re-employed ex-servicemen working under your administration/jurisdiction before 01.01.2006 and after 01.01.2006 separately.

15. Sir, kindly arrange to provide the all certified true copies of latest pay slips for the months from Apr, May and Jun 2016 of all those re-employed ex-servicemen working under your administration/jurisdiction before 01.01.2006 and after 01.01.2006 separately.

16. Sir, kindly provide the all above information point wise and para wise from Ser No. 1 to 15 please.
