#### 4. NATIONALITY / CITIZENSHIP

Candidate must be a Citizen of India.

#### 5. SELECTION PROCEDURE:

The Selection would be done by way of group discussion and / or interview. Merely satisfying eligibility norms does not entitle a candidate to be called for Group Discussion/Interview. IIFCL reserves the right to call only the requisite number of candidates for the Group Discussion/ Interview after preliminary screening / short listing with reference to candidate's qualifications, experience, suitability, etc. The decision of IIFCL shall be final and binding.

#### 6. PLACE OF WORK

The place of work shall be presently at the corporate office of IIFCL at New Delhi. However, IIFCL reserves the right to post selected candidate to any of its offices/subsidiaries in India/Abroad.

#### 7. SERVICE BOND (For direct recruitment):

Selected candidates are to undertake service bond of Rs. 2 lac for actively serving IIFCL for a minimum period of 2 years after joining.

#### 8. SPECIFIC CONDITIONS: (Deputation: Post Code: 01)
