Information Sought :	<p>A recruitment notice was published by IIFCL on 05 July 2016 for post of assistant manager and many aspirants like have filled the form.</p> <p>After 2 years in Feb 2018 the company sent letter to many of us that written and GD will be conducted on 2 Feb and thereafter on 28 GD interview will be conducted for shortlisted candidates only. On such as short notice I have requested for NOC from my govt bank to appear in the written and interview. Many of us have taken leave for 2 days i.e 27 and 28th Feb. Then after the interview it was told that the final result will be declared till 9th March. We were in regular contact with the HR and she confirmed that they have taken approvals and result will be declared by March end. Then on 3rd April said that result will be declared by 5th and on 5th we came to know from website notice section that the recruitment process stands cancelled and inconvenience cause regretted. I am really shocked about the fact that government organisations also do such things and don't think even for a second for the aspirants.</p> <p>I would also like to bring to your kind notice that max age criteria for the post was 30 years in 2016 which many of us has already passed by on 2018 hence we won't be able to apply for this post ever in future. What we have got after wait of good 2 years, cracking written and interview. A cancellation without any apology.</p> <p>I would like to know following facts</p> <ol style="list-style-type: none"> 1 On what basis the vacancies were decided in 2016 and with whose permission the vacancies were declared in newspaper. 2 Why the company have taken 2 years time to declare shortlisted candidate for written exam and out of how many applications those have been selected and on basis of what 3 After taking whose approvals and permission the written GD and interview were taken. 4 Why and with whose permission the recruitment stands cancelled. 5 Why the cancellation of the request has not been published in newspaper as the notice of vacancies did. 6 What approvals have been taken before cancelling the recruitment. 7 What happens to the vacancies that were declared in 2016 and cancelled in 2018. Is IIFCL short of staff or were those vacancies created just like that. <p>I would like to request to the ministry as well to look into the matter and revoke the cancellation and publish name of successful candidates as it is not about image of one</p>		

individual or government organisation. ONE REPRESENTS THE ALL AND IT HAS SHAKEN OUR TRUST ON RECRUITMENT PROCESS IN GOVERNMENT ORGANISATIONS.IT IS ABOUT OUR FUTURE NOT ABOUT 4 VACANCIES.
