| Information Sought : | <p>COMPLAIN REGARDING THE CANCELLATION OF THE RECRUITMENT PROCESS FOR THE POST OF ASSISTANT MANAGER (GRADE A) OF THE ADVERTIZEMENT DATED 5th July IN ECONOMIC TIMES.</p> <p>I (CHARU DHAMIR) applied in july 2016 for the post of Assisitant Manager (Grade A) in (IIFCL) by sending my application.</p> <p>I waited for the revert and after approx. 19 months on 13/February/2018 I received the mail from the HR (Suman Ruhel) email id: suman.ruhel@iifcl.org that You are requested to attend the writing skills examination & Group discussion for the post of assistant manager in IIFCL on 27/02/2018 @ 10:00 AM. The call letter was attached in the mail.</p> <p>I checked on the website and found out that my name was under shortlisted candidate for writing skills examination & Group discussion for the post of assistant manager in IIFCL.</p> <p>On 27/02/2018 @ 10:00 AM, I attended the writing skills examination & Group discussion for the post of assistant manager in IIFCL , 8th Floor ,Hindustan Times Tower , 18 & 20 KG Marg Connaught Place, New Delhi- 110001. There were two rounds . 1st was of writing skills and the 2nd was group discussion.</p> <p>On 28/02/2018 I received a call from the HR at approx. 12:30 PM as well as it was published under interview column on the website that I have been shortlisted for an interview and I have to immediately come for an interview to IIFCL office.</p> <p>I attended the interview on 28th February 2018 at 2 PM along with 15 other shortlisted candidates. The HR confirmed that the result of the same will be published latest by 10th march 2018.</p> <p>I was in continuous follow up with the HR on the IIFCL landline number regarding the result and I was every time confirmed that the result will be published next week. On 2nd of April I again contacted the HR on the landline number and finally she said that results have come and will be published latest by this week so keep on checking the result column.</p> <p>I was everyday checking the result column and suddenly on 5th April evening I received a call from one of the candidate that the notice has been published under notice tab in the IIFCL site stating that the recruitment process for the four posts</p> | | |

advertised in Economic Times 5th July, 2016 for assistant manager (Grade A) stands cancelled, inconvenience caused is regretted.

I want to complain that:-

- 1) Why shortlisting process took approx 2 years.
- 2) Why in an emergency the next day after publishing the result for writing skills and group discussion at 12:30 PM candidates were called by 2 PM for an interview.
- 3) Why the reason for cancelation was not informed.
- 4) Suddenly publishing that the recruitment process has been cancelled has caused deep mental harassment and emotional misbalance.

Also the completion of the recruitment process is expected by revoking the cancellation notice.

- 5) Also as I am deserving candidate , then why I was not informed of the valid reason of cancellation , and being my right I want the selection process to be completed as soon as possible.
