a.	What is the Validity of an Ex-servicemen quota in civil services. Is it only for 3 years from date of retirement or till the time as ESM secures civil employment.	IIFCL being an officer's based organisation recruits employees only in Group A category and follows Government guidelines issued regarding relaxation to ESM in recruitment process.
b.	Rules of transfer for re-employed ESM especially in Public sector banks (SBI/RBI etc.) and SSC also.	IIFCL is a Delhi based organisation and presently has single office in India. Accordingly all the employees of IIFCL are posted in Delhi only.
c.	Criteria for pay fixation of re-employed exservicemen in C & D posts in public sector banks (SBI/RBI etc).	IIFCL is an officer's based organisation and presently, has only one employee in GROUP D (who is not an ESM) Further, Government guidelines issued regarding pay fixation of re-employed ex-servicemen are applicable to IIFCL.
d.	Applicability of DA on pension and the pay protected for re-employed ex-servicemen in C & D posts in Public sector banks (SBI/RBI etc.)	Same as reply at point 'c' above.
