Has this been considered to decide seniority.	Chairman & Managing Director (CMD) of IIFCL was holding additional charge of CMD-IWRFC as well. Accordingly, IWRFC was an associated company of IIFCL. Employees of IWRFC were working in IIFCL as part of their on-the-job training. Seniority has been decided as per the terms of merger issued vide letter dated F.No.24/1/2016-CL-III dated 21 July, 2016.
6.	What are the promotional aspects of erstwhile employees of IWRFC and how interest of women employee protected.	Since post-merger, they have become the employees of IIFCL, promotional aspect of all the employees of erstwhile IWRFC including women employees will be dealt as per IIFCL's policy.
