- (2) What is the job responsibility and powers of CEO of IAMCL?
- (3) On what criteria/policy Mr. Anil Kumar Taneja has been appointed as CEO of IIFCL Asset Management Company Ltd. on contract basis with effect from March 2020? Please also provide the file noting's.
- (4) Who is the authority empowered to finalize the CTC of CEO of IAMCL?
- (5) What is the criteria on basis of which the CTC of CEO of IAMCL is finalized?
- (6) How much CTC has been approved for Mr. Anil Kumar Taneja CEO W.e.f. his appointment w.e.f. March 2020? Please also provide the file noting's.
- (7) How much payments have been made to Mr. Anil Kumar Taneja w.e.f. March 2020 on account of monthly fee / salary and other reimbursements? Please also provide the file noting's.
- (8) Whether PF is payable for Mr. Anil Kumar Taneja and if so, whether it is component of CTC or under separate head?

(9) Please provide details of TDS deducted on payments made to Mr. Anil Kumar Taneja w.e.f. March 2020?
