  - 4) As per the reply to the previous rti (page 1 of copy attached), the notification dated 31 Jan 2019, issued by the DFS regarding enhancement of employer contribution to 14 percent from 10 percent is applicable to only central government employees but two of the organization under DFS which are Reserve Bank of India and Pension Fund Regulatory and Development Authority which are not central government organizations have already implemented 14 percent of employer side contribution for NPS (page 2 and 3 of copy attached). In this regards it is requested to please provide the permission document issued by DFS showing the necessary permission is given to RBI and PFRDA which allows them implementing 14 percent of employer side contribution for NPS.
