Is the reservation given in direct recruitment for bank and financial institutions recruitment for candidates with temporary certificate of disability which is valid for a certain period and the condition is progressive? As the section 34(1) of the person with disability act, 2016 4% reservation for pwbd is applicable to pwbd with permanent certificate of disability or with temporary certificate of disability which is valid for a certain period and the condition is progressive.

2. Does The recruiting institution has to mention about the above condition in their advertisement specifically? What if they dont mention it in the advertisement for recruitment.

You are requested to provide the information within the time frame as many people with disability will benefit from this critical information.
