

As regard to Query 2-4, where it is queried about various positions available in CPSEs, procedures to recruit personals in CPSEs and vacancy position in CPSEs it is to informed that all such matters are related to internal administrative matters of CPSEs. Moreover, these all vary according to needs, situation and requirements of various CPSEs and are decided by Managerial Board in coordination with respective Ministries/Departments only.
